Well #1 SEQR After explanation by Superintendent Boberg, motion was made by Mayor Krebs, seconded by Trustee Pazzuti; carried, Mayor Krebs, Trustee Pazzuti, Skelton and Wikman voting yes, none opposed, Trustee Braman abstaining due to connectivity issues naming the Village of Springville Board of Trustees as the Lead Agency in the SEQR for the Well #1 project.

Motion was made by Mayor Krebs, seconded by Trustee Wikman; carried, Mayor Krebs, Trustees Wikman Skelton and Pazzuti voting yes, none opposed, Trustee Braman abstaining due to connectivity issues to approve the unlisted short form and declare a negative declaration pertaining to the Well #1 project SEQR.

WHEREAS, *over the years, **People Inc.** expanded its mission and services to support even more people with intellectual and developmental disabilities, older adults and the general public to live, work and thrive to be independent, to have access to affordable and safe housing, all while promoting independence and fulfilling experiences; and*

WHEREAS, ***People Inc.** has become one of the region's largest employers, having a significant economic impact on our local economy and contributes tens of millions of dollars to it annually; and*

WHEREAS, *Orchard Senior Living on Waverly St is a quality senior citizen residential facility providing 42 senior housing units in our Village since 2013, and*

WHEREAS, ***People Inc.** will provide professional care for six individuals with disabilities at its new Mill St residential home, and*

WHEREAS, ***People Inc.** employees ten residents of the Village of Springville. and*

WHEREAS, ***People Inc.** currently supports over 10,000 individuals with developmental disabilities, providing independent housing for over 1,000 seniors at locations throughout Western New York; and*

WHEREAS, ***People Inc.** has also answered the call for assistance in times of need for smaller non-profit organizations, offering an array of affiliations that have preserved a variety of services in jeopardy of closing;*
