Whereas, the Village of Springville has need for a permanent Clerk and Treasurer (combined for these purposes, as Clerk/Treasurer) to conduct daily business and oversight, both titles currently having two year appointments; and

Whereas, it is the desire of the Board of Trustees to increase the length of the term of such offices jointly; and

Whereas, the Board of Trustees has the authority to change such terms by resolution according to the New York State Council of Mayors;

NOW, therefore be it resolved that;

The Village of Springville extends the term in Article II of the Village code to four years for both the Clerk and the Treasurer title; and

The Village of Springville recognizes that the term will run concurrently with the mayoral term; and

Any interim appointment will serve in that capacity until the reorganizational meeting following a mayoral election unless otherwise deemed unfit to continue.

After the Pledge to Allegiance, Chairman Muhlbauer called the meeting to order at 7:01 pm.

Tonight, on the agenda the Planning Board is addressing the following Public Hearing:

Application # 10756, for Special Exception approval, located at 178 East Hill Run, Springville, NY, SBL 336.18-2-15 R8.5 Brittny Rehrauer for Home Occupancy Office.

Chairman Muhlbauer asked the applicant to come forward to explain what it is she is planning to do. Ms. Rehrauer explained she is adding a room on the back of the house to provide personal spa services as she is a licensed cosmetologist. She explained that she has a full-time job outside of her home as an occupational therapist and would like to make extra income to help make ends meet and would only provide services on Saturdays by appointment only.

Chairman Muhlbauer asked if she had any drawings and was told not yet but it will be a small room. Code enforcement officer John Baker said it would be considered a residential alteration and would have to meet setback requirements. Member Greg Keyser asked if the addition would occupy less than 30% of the gross floor area and would meet the characteristics of the existing house and was told it would. Parking will not be an issue as will never have more than one client at a time so will be able to park in the driveway. He also asked about advertising with a sign or selling any products and she said she would not be doing either.
